### **Cart Fees**

Utility fees can be found in the City of Courtenay's 'Fees and Charges Bylaw No. 3129, 2024'. The fee for additional cart(s) will be prorated based on the month the application and payment are received. For example, if you submit your application for an additional 120L garbage cart in May a payment of \$80.62 is due.

Note: 'HHW' refers to Home Healthcare Waste and applies to incontinence products and diapers. The reduced rate is available for households requiring the additional cart for these products.
